

PERMIT INFORMATION

Enclosed is the application for the purchase of stickers for 2008/2009 (see below for validity dates for each sticker).

Stickers and passes may be purchased through the Sticker Office, either in person or by mail. **Please note that a discount is offered on some permits if purchased by mail.** The Sticker Office is located at the Mashpee Town Hall, 16 Great Neck Road North. Hours for sticker sales are Monday through Friday, 9 a.m. – 4 p.m..

Transfer Station and Recreation Stickers may also be purchased on Saturdays and Sundays, June 14 – August 24, at the Mashpee Chamber of Commerce Welcome, 520 Main Street. The Welcome Center will be open from 9 a.m. – 3 p.m.

NEW! Beginning this year, payment may be made by credit card on the Town's web site. Go to www.ci.mashpee.ma.us for details. Receipt of your credit card transaction must be included with your completed application.

FY09 TRANSFER STATION STICKER (valid July 1, 2008 – June 30, 2009)

A Sticker or Pass is required to use the Mashpee Transfer Station. ***Only Mashpee residents or residential property owners are eligible to purchase stickers or passes.*** Visitors to Mashpee may purchase passes.

2008 RECREATION STICKER (valid June 14, 2008 – September 1, 2008)

A Sticker is required during the summer season to use the three public beaches in Mashpee (South Cape Beach, Attaquin Park, and John's Pond) and the four Town boat ramps (Great River, Ockway Bay, Pirates Cove, and Santuit Pond). Town stickers are not accepted at the State Boat Ramps. Parking is on a first come, first serve basis. ***Only Mashpee residents or residential property owners are eligible to purchase permits. Time-share owners are eligible for weekly beach passes only.*** For visitors to Mashpee, a weekly pass to use the beaches may be purchased. Tribal members may access the beach by displaying their tribal sticker on the vehicle or showing their Tribal ID.

2008/2009 SHELLFISH LICENSE (valid from April 1, 2008 – March 31, 2009)

A permit is required for the taking of shellfish from the waters of Mashpee. Users of a family permit may include the permit holder, his or her spouse, and their children under the age of 18 years. ***Mashpee residential property owners may purchase a family permit at the resident rate. Non-residents who do not own property in Mashpee may purchase a permit at the non-resident rate, provided they reside elsewhere in Massachusetts.*** Tribal members may access the beach by displaying their tribal sticker on the vehicle or showing their Tribal ID.

THE FOLLOWING IS REQUIRED AT THE TIME OF PURCHASE:

1. **Completed application**
2. TRANSFER STATION AND RECREATION STICKERS ONLY **Copy of current vehicle registration** for each vehicle for which a sticker is requested. If vehicle is leased, a copy of the Lease Agreement is required. If your vehicle is registered to a business, documentation linking you to the business is required.

All vehicles must be registered to the same address. Only two Transfer Station stickers may be purchased per household.
3. SHELLFISH LICENSE ONLY **Copy of driver's license** for each person for whom a permit is requested
4. **If you are a non-resident**, a Mashpee Real Estate Tax Bill, Deed or Purchase and Sales Agreement (for Mashpee visitors, a Lease or Rental Agreement for your Mashpee vacation location is required).
5. **Check or money order** made payable to the "Town of Mashpee" in the total amount due or copy of receipt from on-line credit card payment.
6. If purchasing by mail, **Self-addressed, stamped envelope**.
